

**Toyota Pay My Bill Promotion  
Official Rules**

**NO PURCHASE, SERVICE RECEIPT OR TEST DRIVE NECESSARY TO ENTER OR WIN. A PURCHASE, SERVICE RECEIPT OR TEST DRIVE DOES NOT INCREASE CHANCES OF WINNING. VOID OUTSIDE OF NEW YORK, NEW JERSEY, CONNECTICUT AND WHERE PROHIBITED BY LAW.**

**Dates and Location:** The Toyota Pay My Bill Promotion (“Promotion”) will begin at 12:00AM Eastern Standard Time (EST) on 2/1/20 and end at 11:59PM EST on 3/31/20 (the “Promotion Period”).

**Who is Eligible:** Promotion is open to legal residents of Arizona, Colorado, New Mexico, Nevada, Utah, and Wyoming who are 18 years of age or older, and have a valid U.S. driver's license. Employees, officers, directors and agents of Toyota Motor Sales Denver Region (“Sponsor”), American Hole ‘n One (“Administrator”), DME Delivers, and each of their respective parents, affiliated companies, subsidiaries, distributors, dealers, retailers, printers, advertising and promotion agencies and all other companies associated with the design or execution of this Promotion (collectively, the “Promotion Parties”), and the members of their immediate families (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) or households, whether or not related, of any of the above, are not eligible to enter or win. The Promotion is subject to all applicable federal, state and local laws and regulations. Void outside of Arizona, Colorado, New Mexico, Nevada, Utah, and Wyoming and where prohibited by law.

**How to Enter:** There are two (2) ways to enter during the Promotion Period: **1) Vehicle Service Receipt:** After having your Toyota or Scion vehicle serviced at a participating dealership (see list below), visit [www.toyotapaymybill.com](http://www.toyotapaymybill.com) and follow the instructions provided to submit one (1) entry. Entrants must complete all required information on the entry form to be eligible, including their complete name, mailing address, phone number (including area code), email address, repair order number located on their Toyota or Scion vehicle service receipt (“Repair Order”), and the amount of the repair or service as specified on the receipt. Customer Repair Order must have the entrant’s name on it to be eligible, and dates of service must fall between February 1, 2020 and March 31, 2020. **Service must occur at one of the participating dealerships (listed below), and service must be on a Toyota or Scion vehicle.** All Repair Order online entries must be received by 11:59PM EST on 3/31/20 to be eligible. OR, **2) Mail-In:** To enter without owning a Toyota or Scion vehicle, having obtained service on a vehicle or submitting a Repair Order, hand-print your name, mailing address, email address, daytime and evening numbers (area code included), date of birth, and the name of one of the participating dealership below and mail in a stamped, standard #10 envelope, addressed to: Toyota Pay My Bill, Attn: Mike Rispoli, 2441 Bellevue Avenue, Daytona Beach, FL 32114. Mail-in entries must be postmarked by 3/31/20 and received by 4/7/20 to be eligible. In the event a mail-in request does not specify a participating dealership, Sponsor will randomly assign the mail-in request to the closest participating dealership to entry. Limit one (1) entry per person, per household, per participating dealership, regardless of method of entry, throughout the Promotion Period. You may only use one (1) email address to enter the Promotion. Additional entries submitted from any person or email address in excess of the above stated limitation will be void. Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. Entries that are incomplete or corrupted are void and will not be accepted. Mechanical reproductions and entries generated by any means which subvert the entry process are void. Entries that are forged, tampered with, obtained through illegitimate channels or by any other means that are not compliant with the Official Rules will be void.

service receipts, the announcement of the prizes or in any Promotion-related materials. All fraudulent, incomplete or non-conforming entries will be disqualified. Administrator reserves the right to cancel, modify or terminate any portion of the Promotion for any reason, including if fraud, misconduct or technical failures destroy or threaten the integrity of any portion of the Promotion, in the opinion of the Administrator, or if any problem corrupts the administration, security, or proper conduct of the Promotion as determined by Administrator, in their sole discretion. In the event of early termination of any portion of the Promotion, Administrator reserves the right to conduct a random drawing from among all eligible, non-suspect entries received from all participating dealerships as of such termination (as applicable). Proof of an entry will not be deemed to be proof of receipt by Administrator.

**Promotion Prize Allocation & Winner Notification:** Administrator will conduct a random drawing for each participating dealership on or about 4/20/20 to select one (1) potential Grand Prize winner for each participating dealership from among all eligible entries received for each participating dealership in accordance with these Official Rules (for a total of 67 potential Grand Prize winners throughout all participating dealerships). Odds of winning depend on the number of eligible entries received for each participating dealership. Potential Grand Prize winners may be notified by phone and/or email on or about 4/20/20 and asked to confirm his/her eligibility, and indicate his/her willingness to accept the Grand Prize as described below. Upon confirmation of his/her eligibility as well as his/her willingness to accept a prize, potential Grand Prize winners will be required to execute and return a W-9 form, an affidavit of eligibility and liability and, unless prohibited by law, publicity release within two (2) days of date of issuance of notification. If a potential Grand Prize winner is ineligible or otherwise fails to return such documents within the specified time period fully-executed, or if Administrator is unsuccessful to reach and speak directly with a potential Grand Prize winner by phone over a 48-hour period, a potential Grand Prize winner cannot or does not wish to accept the prize or is not in compliance with these Official Rules, such potential Grand Prize winner will be disqualified and, at Administrator's discretion, an alternate winner may be randomly selected and notified as per the procedures outlined above. Failure to collect or properly claim the Grand Prize in accordance with these Official Rules will result in forfeiture of the prize. If forfeited for any reason, Administrator will have no further obligation to such winner and may, at its sole discretion, randomly select an alternate winner who will be notified as per the procedures outlined above.

**Grand Prizes (67) (One (1) per participating dealership):** A check equal to the cost of the vehicle Repair Order submitted by winner in his/her entry, up to \$1,000. Maximum approximate retail value ("ARV") of each Grand Prize: \$1,000. Minimum value of each Grand Prize: \$250 (i.e., if the cost of the vehicle Repair Order submitted by a winner in his/her entry is \$100, the winner will receive the minimum \$250 prize check). If a mail-in entrant is selected, s/he will receive a check in the amount of \$500. Maximum total ARV of all Grand Prizes: \$67,000.

**General Prize Conditions:** All costs and expenses related to prize acceptance and use not specified herein as being awarded, including, but not limited to federal, state and local taxes, are the sole responsibility of the winners. Prizes are non-transferable, and no cash redemption or prize substitution allowed, except at Administrator's sole discretion. **Additional Rules & Restrictions:** By participating in this Promotion, participants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor and Administrator, which shall be final and binding in all matters relating to this Promotion.
